### LETTER TO THE UNIVERSITY COMMUNITY

#### University Colleagues,

On behalf of the Division of Enrollment Management and Marketing, I am pleased to present DePaul's 2017 enrollment summary. This annual report describes the current enrollment profile and how it has changed over recent years as we have pursued DePaul's ambitious enrollment goals.

Overall, the university enrolled 22,769 students this fall, nearly 2 percent over the budgeted target. While surpassing that projection is noteworthy, it is important to note that the budgeted target anticipated a significant decline. Total enrollment is only 341 students less than last fall.

Enrollment planning is becoming increasingly unpredictable. The demographic and economic forecasts in the state of Illinois and the region are not favorable, and the growing number of students with considerable financial need requires a greater investment in grants and scholarships. These are very real challenges that will continue to impact us, as they do every university.

There is considerable volatility in the patterns that underlie our overall enrollment—at the college and program level, as well as by student segment. For example, despite gains in technology, digital arts, business and health programs, declining enrollment in areas such as liberal arts and competency-based adult programs have led to significant enrollment decline among undergraduates. While DePaul continues to enroll significantly more transfer students than any private university in Illinois, the number of transfers has declined from its peak in 2011.

The pages that follow illustrate how changes by program and student population impact DePaul's overall enrollment profile. While they provide a high-level view of the challenges we face in an increasingly competitive market, they also show how our broad portfolio of academic programs positions us to successfully balance our enrollment outcomes.

As this booklet goes to print, the university is in the process of developing a new strategic plan. That plan, anticipated to be finalized by June 2018, will provide clear priorities that will frame our future enrollment planning.

As with any plan, it will only be as strong as the people charged with implementing it. In that, we are fortunate, because of the extraordinarily talented and dedicated faculty and staff at DePaul. Your unwavering commitment to the success of our students continues to be the key to DePaul's future. Thank you for all that you do.

### **UNIVERSITY ENROLLMENT**

DePaul remains the nation's largest Catholic university for the 20th consecutive year, with a total student enrollment of 22,769.

**Undergraduate Enrollment** – 14,816 students enrolled this fall, compared with 15,407 in 2016. Undergraduate enrollment accounts for 65 percent of total enrollment in 2017, compared with 67 percent in 2013.

**Graduate Enrollment** – 7,130 students enrolled this fall, compared with 6,897 in 2016, accounting for 31 percent of university enrollment.

**Law Enrollment** – 823 students enrolled this fall, up 2 percent from 2016. Law enrollment accounts for 4 percent of university enrollment.

Students registered for a total of 283,408 credit hours in fall 2017. Seventy-seven percent of these credit hours were generated by undergraduate courses and 23 percent by graduate and law courses.

DePaul's total enrollment represents a diverse student body in terms of ethnicity, gender and other demographics.

- >> 43 percent are students over 24 years of age.
- » 53 percent are female.
- >> 38 percent are students of color.
- >> 7 percent are international students (on all visa types).



### **UNDERGRADUATE ENROLLMENT**

DePaul enrolled 14,816 undergraduates this fall, compared with 15,407 in 2016. Undergraduate enrollment has declined 10 percent from a peak of 16,498 students in 2012, driven disproportionally by a decline in part-time enrollment. While part-time enrollment accounts for only 13 percent of undergraduate enrollment, the decline in part-time students since 2012 accounts for over half of the decline in undergraduates between 2012 and 2017.






# **FRESHMAN ENROLLMENT**

DePaul welcomed a class of 2,542 new freshmen in fall 2017, a 3 percent increase from last year's class of 2,459 students. Enrollment increased in all colleges with the exception of CMN. BUS continues to enroll the largest proportion of freshmen at 25 percent.

### **By Academic Profile**

The freshman class is strong on all measures of academic preparedness.

- >> The average high school GPA—the best predictor of academic success at DePaul—is 3.60, up from 3.55 in 2016, and the second-highest in university history behind 3.65 in 2013.
- » The average ACT composite score of all DePaul freshmen is 25.3,\* the same as last year. The middle 50 percent of the class scored between 22 and 28. Nationally, the average ACT composite score is 21.0.
- » About 10 percent of the freshman class, or 247 students, enrolled in the university's Honors Program\*\* in fall 2017, compared with 267 in 2016. A total of 76 percent of the new honors students had ACT composite scores of 28 or above, compared with 30 percent of the freshman class.
- >> Freshmen came from almost 1,000 high schools, with the top 25 high schools accounting for 20 percent of the class. Freshmen enrolled in nearly 100 different majors.
  - \* ACT average includes scores for students who applied through the test-optional program and submitted scores post-admission for research purposes.
- \*\* There are five other college- and discipline-specific honors programs at DePaul. The information presented here does not include those programs.



## TRANSFER ENROLLMENT

Enrolling in fall 2017 are 932 traditional-age transfer students (under 24 years of age) and 311 adult transfer students (24 years of age and older), compared with 967 and 427, respectively, in 2016. Enrollment of traditional-age transfer students declined 4 percent, while adult enrollment declined 27 percent. The decline in adult transfers is due primarily to the discontinuation of SNL's competency-based degree. Historically, SNL has enrolled about 40 percent of all new adult transfer students.


The three largest colleges for total new transfer enrollment—BUS, LAS and CDM—together enroll 67 percent of new transfers. Enrollment in LAS, CDM, CSH and Music is comparable with 2016, with declines in the other colleges. Sixty-one percent of transfers come from Illinois community colleges. Forty-two percent of this fall's new transfers enter DePaul with sophomore status, and 36 percent with junior status. Ninety-one percent of new transfers are full-time, compared with 83 percent in 2013.

Transfer students remain an important component of DePaul's enrollment profile. This fall, transfers account for 33 percent of new degree-seeking undergraduates, compared with 36 percent in 2016. Throughout 2016-17, DePaul enrolled a total of 2,093 transfer students and 2,491 freshmen. Sixty-seven percent of transfers in 2016-17 began their enrollment in fall quarter, compared with 64 percent in 2012-13.






### Transfer Enrollment by College

### FRESHMAN AND TRANSFER DEMOGRAPHICS

#### Freshmen

#### **By Gender**

- >> Less than half of all new freshmen are male (44 percent) in 2017, compared with 42 percent in 2013.
- Denrollment in COE, CSH, CMN, LAS and Theatre is more than 65 percent female.

### **By Geography**

- > 45 percent come from suburban Chicago or elsewhere in Illinois, 36 percent from out of state or out of country, and 19 percent from the city of Chicago.
- » Michigan is the top state for freshmen (other than Illinois), sending 109 new freshmen this fall. Rounding out the top five are California, Ohio, Minnesota and Wisconsin.
- The 912 out-of-state freshmen come from over 650 high schools throughout the nation.
- The number of African-American freshmen from out of state has increased 43 percent since 2013.
- » 68 percent of new freshmen live on campus.

### **First-Generation Freshmen**

- » Enrolling this fall are 844 freshmen from families where neither parent has a bachelor's degree. First-generation students represent 33 percent of the freshman class.
- » Over a third of new freshmen in CSH, BUS, CMN and COE are first-generation.
- » A total of 45 percent of this year's first-generation students come from suburban Chicago.



### FRESHMAN ADMISSION TRENDS

DePaul received 21,613 freshman applications for fall 2017, compared with 22,502 in 2016. A total of 2,081 students applied through the test-optional program.

- » CSH received the most applications of any college with 5,974, or 28 percent of all applications.
- » CDM accounted for 13 percent of applications in 2017, comparable with 2016.
- > 44 percent of applications came from outside Illinois; 32 percent were from Chicago suburbs; 25 percent were from Chicago.
- » California, Michigan and Ohio provided the most out-of-state applications.

## **TRANSFER ADMISSION TRENDS**

Transfer applications increased this year to 5,130, up 3 percent from 4,993 in 2016. Applications increased in all colleges except CMN, SNL and Theatre. Together, BUS and CSH accounted for 46 percent of transfer applications.



### **RETENTION AND GRADUATION RATES**

Returning in fall 2017 for their sophomore year are 84 percent of the fall 2016 full-time freshmen, compared with 85 percent of the prior year's freshman class.

One of the most significant trends is the continued improvement in the four-year graduation rate over the past 10 years. This year, the four-year graduation rate for the 2013 freshman class was an all-time record 60 percent, up from 59 percent the last three years.

Of the fall 2011 full-time freshmen, 71 percent had graduated from DePaul six years later, down slightly from the past two years.




### THE FOUR-YEAR GRADUATION RATE FOR FRESHMEN HAS INCREASED SIX PERCENTAGE POINTS IN THE LAST SIX YEARS.

The transfer one-year retention rate captures the percentage of new transfer students from all terms of the prior year\* who return for the fall term. Because the methods for calculating freshman and transfer retention rates are different, the rates should not be directly compared.

The transfer retention and graduation rates have been relatively stable over recent years. This fall, the one-year retention rate is 81 percent. Sixty-one percent of students who transferred to DePaul during the 2013-14 academic year graduated within four years. The six-year graduation rate for students who transferred during the 2011-12 academic year is 66 percent.

### **GRADUATE AND LAW ENROLLMENT**

### **Graduate Enrollment**

In fall 2017, a total of 7,130 graduate students enrolled (excluding Law), up 3 percent from 6,897 students in 2016. Enrollment in KGSB (the largest graduate college), COE, CSH and CMN increased in 2017. A total of 90 percent of all graduate students are master's degree students, 8 percent are doctoral students, and 2 percent are in certificate programs or non-degree seeking.

- » 67 percent are enrolled full time, taking eight or more credit hours per quarter, up from 61 percent in 2013. Full-time graduate enrollment varies by college. The colleges with primarily full-time graduate enrollment include Theatre (100 percent), CMN (81 percent), CSH (77 percent), Music (75 percent), COE (72 percent) and KGSB (70 percent). The largest proportion of part-time graduate enrollment is in SNL (88 percent).
- >> 49 percent of all graduate students are 24 to 29 years old, comparable with 2013.
- » 32 percent are students of color (2,304 students), compared with 28 percent in 2013.
- » 53 percent are female, comparable with 2013.

#### Law Enrollment

A total of 823 students enrolled in Law this fall, a 2 percent increase from 2016. Most law students are enrolled in the JD day program—75 percent—and 14 percent in the evening program, 9 percent in the Master of Jurisprudence (MJ) program and 2 percent in the LLM program. Enrollment in the MJ has increased 36 percent from 2016.

- >> 42 percent are originally from out of state or international locations (44 percent in 2013). Michigan, Indiana, California and Florida are the largest feeder states for current law students.
- >> 57 percent are female (53 percent in 2013).
- » 26 percent are students of color (21 percent in 2013).
- >> 28 percent are under 24 years of age (31 percent in 2013).





### **NEW GRADUATE ENROLLMENT**

### **New Master's Enrollment**

A total of 1,633 new master's students enrolled in fall 2017, up 26 students from 2016.

- > 69 new master's students are enrolled in almost 30 combined degree programs that allow students to complete their bachelor's degree and master's degrees together in five years, compared with 52 in 2016. Sixty-one percent are female (54 percent in 2016).
- » Most new master's students in Theatre and Music are originally from out of state (92 and 70 percent, respectively), compared with about a quarter in CMN, CDM and LAS (30, 24 and 23 percent, respectively), and less than 20 percent in COE, KGSB, CSH and SNL.
- » 30 percent are under 24 (28 percent in 2016).
- >> 33 percent are students of color (32 percent in 2016).
- » 14 percent are international students on F1 and J1 visas (17 percent in 2016).



by College




### New Partnership Program Enrollment

Since introducing the Corporate and Employer Outreach (CEO) program in 2014, DePaul has established 25 connections with Chicago companies and delivered programming to more than 600 new students. This fall, 111 new graduate students and 21 new law students enrolled through the CEO program in five on-site cohorts. In addition, another 27 new transfer and graduate students enrolled in one of DePaul's other academic programs and are employed at a partner institution.

#### New Doctoral Enrollment

A total of 103 new doctoral students enrolled this fall, compared with 118 in 2016. Forty-five students are in COE, 36 students are in CSH, 11 are in KGSB, six are in CDM and five are in LAS.

#### New Law Enrollment

Law welcomed 309 new students this fall, compared with 321 students in 2016. Of the new law students, 271 are enrolled in the JD program, 28 are enrolled in the MJ program, and 10 are in LLM programs.



### A RECORD 33 PERCENT OF NEW GRADUATE STUDENTS ARE STUDENTS OF COLOR. COMPARED WITH 28 PERCENT IN 2013.

Credit hours generated at the Lincoln Park and Loop campuses were equivalent in 2017 (42 percent from each campus). Online course credit hours increased to 32,784, up 6 percent compared with 2016 and account for 12 percent of all fall credit hours. Off-campus locations (including on-site partnerships, Cinespace and Rosalind Franklin University of Medicine and Science) generated 5,981 credit hours in 2017, a 50 percent increase from 3,998 in 2016. Overseas and study abroad locations generated 5,539 credit hours, a 27 percent increase from 4,360 in 2016.

The proportion of students taking some online courses has increased from 12 percent in 2013 to 19 percent in 2017 (2,868 and 4,386 students, respectively), while the proportion of students taking exclusively online courses has been relatively constant at about 8 percent (1,870 and 1,892 students, respectively). Of undergraduates, 25 percent took some online courses and 5 percent took exclusively online courses. Of graduate students, 10 percent took some online courses and 16 percent took exclusively online courses. Of undergraduate and graduate students enrolled exclusively online, most are enrolled part-time (83 and 65 percent, respectively) and are from the Chicago metropolitan area (87 and 67 percent, respectively).

#### International Students on F1 and J1 Visas

In total, 1,467 students have international student status (on F1 and J1 visas), compared with 1,603 in 2016. This year, one-third of international students are undergraduates, and two-thirds are graduate and law students. International students represent 6 percent of total university enrollment.

#### International Undergraduate Enrollment Trends

- » There are 483 undergraduate international students (or 3 percent of all undergraduates).
- » International students are enrolled in all colleges; nearly half enrolled in BUS (48 percent).
- International undergraduates come from more than 70 countries. China is the largest source, accounting for one-third of international undergraduate students, followed by Saudi Arabia and South Korea.

#### International Graduate and Law Enrollment Trends

- > A total of 984 international graduate and law students (or 12 percent of all graduate and law students) enrolled in 2017, compared with 1,051 in 2016. The largest proportion of these students enrolled in CDM and KGSB (43 percent and 38 percent, respectively).
- International graduate students come from about 70 countries, with nearly one-third from China, followed by Saudi Arabia and India.
- International law students come from over 15 countries. China is the largest source, followed by Canada and Spain.

### NATIONAL COMPARISONS

DePaul is the largest private, not-for-profit university in the Midwest and the 13th-largest private institution nationally. DePaul has been the largest Catholic university in the nation for 20 consecutive years, having exceeded St. John's University in total enrollment in 1998. DePaul enrolled 11 percent of the enrollment at the 15 largest Catholic institutions in 2017.

Since 2008, enrollment at the largest Catholic institutions increased by 4 percent to 207,723 students, an increase of 8,249 students. From 2013 to 2017, enrollment at these institutions remained largely unchanged, decreasing by 229 students.
