

Preface

This year's *Fact File* incorporates several formatting revisions designed to reflect the changing nature of certain aspects of the University and the changing data needs of *Fact File* users. Below is a summary of these formatting changes for AY95-96.

1. Data concerning the School of Computer Science, Telecommunications and Information Systems (CTI) is reported independent of the College of Liberal Arts and Sciences. In previous editions of the *Fact File*, CTI programs were reported under the Computer Science Department of the College of Liberal Arts and Sciences.

- ◆ *Undergraduate* CTI programs include the Computer Science degree program and the following certificate programs through the Institute for Professional Development: C++ Programming, Client Server Technology, Computer Careers, Database Management, Executive Computing, Local Area Networks, Telecommunications, and Windows Software Development.
- ◆ *Graduate* CTI programs include degrees in Computer Science, Information Systems, Management Information Systems, Software Engineering and Telecommunications.
- ◆ The following tables (identified by Section and Number) were modified to reflect the separation of CTI from LA&S: 1-1, 1-2, 1-3, 1-5, 2-1, 2-2, 2-4, 2-5, 2-6, 2-8, 2-10, 2-11, 3-3, 3-4, 3-6, 3-13, 3-16, 3-17, 3-22, 4-1, 4-2, 4-3, 4-4, 4-5, 4-6, 4-7, 6-6, and 7-2. Section 5 is concerned with degrees awarded. Because CTI did not exist as a separate school in AY94-95, Computer Science degrees awarded in AY94-95 were conferred through LA&S. For this reason, Section 5 retains the old format of reporting Computer Science as a department within LA&S.

2. College of Law enrollment data have been separated according to enrollment in J.D.-Day, J.D.-Evening and LL.M. degree programs. In previous years, College of Law enrollment data was reported according to Law-Day and Law-Evening programs only. LL.M. programs were aggregated with J.D. programs in those years.

- ◆ The following tables (identified by Section and Number) were modified to reflect the separation of J.D. and LL.M. enrollment data: 1-1, 1-2, 1-4, 1-5, 2-1, 2-2, 2-4, 2-5, 2-6, 2-8, 2-12, 3-20, and 3-21.

3. Faculty headcounts reported in the *Fact File* may not match headcounts reported in the Academic Information System report. Full-time faculty headcounts reported in the *Fact File* are obtained at the beginning of the academic year. The Academic Information System summarizes headcounts at the close of the academic year. This time differential in data collection accounts for any headcount discrepancies between sources.

- ◆ The tables (identified by Section and Number) affected by this time differential include 7-1, 7-2, 7-3, and 7-4.

4. New, Discontinued and Modified Degree Programs. Below is a list of changes, stratified by college, in the degree and certificate programs offered at DePaul.

- ◆ Commerce. *Strategic Management* graduate program was added (weekend MBA).
- ◆ CTI. Students enrolled in all certificate programs are counted as undergraduates. The *CICS* certificate program has been discontinued.
- ◆ Education. Those graduate students currently reported as enrolled in the *Teaching and Learning* program were previously reported in the Curriculum Development program.
- ◆ Law. Students enrolled in the *Joint JD/MBA* program were previously reported under Business/Law. Beginning with Fall 1995, these students are reported once in the J.D. division and again in their respective graduate Commerce program. The enrollment in this program is footnoted in Table 1-5. The overall University enrollment figures reflect this duplication in headcounts.
- ◆ LA&S. The graduate program in *International Studies* was added as of Fall 1995.
- ◆ Theatre. The *Child Drama/Youth Theatre* program has been discontinued. *Costume Construction* has been changed to *Costume Technology* and is now offered as a degree program. *Theatre Arts* has been renamed as *Theatre Studies* and includes students enrolled as *Theatre Management* and *Dramaturgy/Criticism*. Although it has been previously listed in the Fact File, the *Directing* program is not offered at the undergraduate level.
- ◆ The tables (identified by Section and Number) affected by the above changes are 1-5 and 5-3.

An electronic version of the 1995 *Fact File* is available on the network. To access the *Fact File*, activate the "Network Applications" group through the Windows Program Manager. Double-click the "Fact File" icon to open all the *Fact File* spreadsheets. (Accessing the electronic *Fact File* requires the installation of Microsoft Excel on your computer.)



Percent Growth in Headcount











Autumn 1995






 Autumn 1991 and Autumn 1995







Autumn 1991 and Autumn 1995




1990-91 through 1994-95



